**Tracing the Alteration Process  
Applied to the Draft April 1924  
by the Department of Legislative Redaction  
(23 พ.ค. 2467 – 25 พ.ย. 2467)**

**Introductory Notes**

The first version of Book III was enacted in January 1925. Its final version in Thai language is included in the “*Archives of the History of Thai Codification*”:<sup>1</sup>

- “ร่างประมวลกฎหมายแพ่งและพาณิชย์ บรรพ 3 กรมร่างกฎหมาย”(Vol. 90 or Vol. 91).

Its original texts in English language could be identified in the following document in the archives:

- “DRAFT CIVIL AND COMMERCIAL CODE BOOK III” (Vol. 88)

It was the result of the final alterations undertaken by the “*Department of Legislative Redaction*” (กรมร่างกฎหมาย) to the “*Draft April 1924*” in 1924 (23 พ.ค. – 25 พ.ย. 2467), which are recorded in the following archive:

- “บันทึกตรวจแก้ร่างประมวลกฎหมายแพ่งและพาณิชย์ บรรพ 3 พระยามานวราชเสวี” (Vol. 89)

All the alterations were recorded, for instance in the report “บันทึก ฉบับที่ ๗” (หน้า 89/28), in the following manners:

- (๑) ในลักษณะให้ เห็นควร **เติมความเข้าอีกมาตราหนึ่ง** คือ มาตรา ๕๓๑ ตี ตามร่างใหม่ข้างท้ายนี้  
(๒) มาตรา ๕๓๖ เห็นควร **ให้แก้ไขใหม่** ตามร่างใหม่ข้างท้ายนี้  
(๓) มาตรา ๕๓๗, ๕๓๘ และ ๕๓๙ เห็นควร **ตัดออก** เพราะมีบทบังคับในลักษณะเดิมแล้ว ...

In the entry No.1 of the Report No.7 – 07(01) –, a new section “๕๓๑ ตี” (“531 ter.” in หน้า 89/29) was **inserted**, and in the alteration 07(02), Sec. 536 was **improved** (หน้า 89/29) while Secs. 537, 538 and 539 were **deleted** in the alteration 07(03).

The section numbers ๕๓๑, ๕๓๖, ๕๓๗, ๕๓๘ and ๕๓๙ in the report are not the section numbers in the Draft 1919. Instead, they exactly correspond to the section numbers in the following archive:

- “คำแปลร่างประมวลกฎหมายแพ่งและพาณิชย์ บรรพ 3 มีนาคม 2466” (**Vol. 86**)

This document (dated March 1924) contains the Thai translation of Secs. 453 – 1139. These section numbers are exactly identical with the section numbers recorded in the “**Reports (บันทึก)**” in the “**Vol.89**”. Furthermore, this document has many handwritten remarks or notes which exactly correspond to the alterations recorded in the “**Vol.89**”. From such circumstances, it is to presume that the document in the “**Vol.86**” was an initial translation of the original text of the “**Draft April 1924**”. Unfortunately, the original text in English of the Draft itself has not been identified in the Archives yet. In this sense, the document in the “**Vol.86**” is the most important source to know of the original contents of the Draft.

## Contents of the Table

The following table describes the alteration process of Sections 453 – 1011 from the 1<sup>st</sup> Report of 23 May to the 41<sup>st</sup> Report of 25 November 1924. The contents of the four main columns are as follows:

- 1) The first main column shows the section numbers in the “**Draft of 1919, Division VII.**” corresponding with sections in the “**Draft April 1924**”.
  - a) The entered content with parentheses, for instance “(676)”, means that this section in the “Draft 1919” was not adopted in the “Draft April 1924”.
  - b) If the entered content is crossed out with a line, then it means the section in question was deleted through the alterations to the “Draft April 1924”.
  - c) If the entered content is simply “-”, then it means that there is no corresponding section.
- 2) The second main column shows the section numbers in the “**Draft April 1924**” recorded in the “**Vol.86**”.
- 3) The third main column describes each operation of the alterations recorded in “**Vol.89**”. Its sub-columns show the section numbers of the reference texts and their position (page number in the archive), kinds of alteration (“**del.**” “**imp.**” or “**ins.**”), the Report-/Entry- numbers, and their position page number in the archive).
  - a) The reference texts (altered texts) are primarily to find in the “**Vol.89**”.

- b) If reference texts are missing in the “**Vol.89**”, sometimes supplementary information is to find in the “**Vol.87**” or in the “**Vol.45**”.
- c) If the entered section number has neither exact position “(??/??)” and nor Report-/Entry-number “??(??)”, then it means that there is no report of alteration despite certain difference between the text in the “**Draft April 1924**” and the text in the “**Draft 1919**”. In such a case, it is reasonable to assume that the text of the “**Draft 1919**” was already changed in the “**Draft April 1924**”.
- 4) The last main column shows the section numbers of the finalized texts in the “**Vol.88**”. Sometimes, the texts have experienced “Second alteration” at the final stage of the revision.

The final candidate for each section in the “**Vol.88**” is indicated with the bold section numbers in red, for instance “**456** (89/10)”.

In this way, we can trace *the alteration process from the “**Draft 1919**” over the “**Draft April 1924**” to the final enactment in January 1925* through *the comparison between “**Draft 1919**”, “**Vol.86**”, “**Vol.89**”, and “**Vol.88**”.*
